Executive Summary:

This report evaluates the online presence of provincial departments of the Khyber Pakhtunkhwah province against the proactive disclosure clause of the KP Right to Information Act, 2013. This report is the second in series of reports to be compiled and launched for the other provincial government departments and federal ministries in Pakistan.

The report found that the official web portal of provincial government of KP is interactive, citizen friendly and filled with useful information of public interest. It gives comprehensive information about the departments. The portal contains a KP Web directory, KP service directory, list of PIOs designated in all departments and process of getting information from a public body through RTI. KP Official web portal provides all information in one link but this shall not undermine the importance of dedicated departmental website. Majority of the departments do not have dedicated websites e.g. food department, planning and development department. The provincial government shall establish websites to improve the web presence of governmental departments.

Despite of having dedicated RTI Sections on the portal and websites, many departments have not followed the section (5) of KP Right Act 2013 in its true letter and spirit. It is based on the fact that the data provided under the RTI sections is either incomplete or irrelevant. The common omissions are the, list of categories of information held by department, latest budget estimates and expenditure, perks and privileges lived up by employees / officers and decision making processes are least disclosed on the web. Section 5 (g) of KP Right to Information Act 2013 requires all public bodies to disclose details of their actual budget and expenditures. According to the report, more than 80% of the departments have shared their annual development programs, provincial citizen budget, white papers but not the actual budget documents (development and non-development) and expenditure details.

On the other hand, the report shows positive trends where most of the departments have designated Public information officers and contact details are also shared. But there is a lot more required to fully follow the section 5 of KP RTI Act, which is the actual criterion of information to be proactively disclosed. Some departments like Agriculture department have also shared a detailed account of number of RTI requests received and processed by the department. Such practice enhances the confidence of a common man on responsiveness of the public body. The Khyber Pakhtunkhwah Right to Information Commission has remarkably followed the criterion of proactive disclosure and secured highest points.

Introduction:

The world is witnessing a digital era where information sharing is quick and through one window of Televisions, laptops and mobile screens. The growing number of internet users and people's online presence has subsequently raised the demand for improving access to government documents through better use of the web; which in turn will lead to openness and transparency through online platforms. This juncture has brought right to information laws at a vertex. Right to information laws bound the government bodies to proactively disclose information regarding the people's interests. With the higher presence of people online, government departments has taken their web presence seriously and tend to be accessible or proactively disclose information through department's website.

Like all good RTI laws, Khyber Pakhtunkhwah Right to Information Act 2013 also has a strong proactive disclosure clause. By proactive disclosure, we mean that certain information should be released to public by the government without citizens sending formal request to information. At CPDI, we believe that right to information regime is basically based on this proactive disclosure of information by government. As right to information culture slowly taking roots in Pakistan, one major observation comes from public officials is that information requests take too much of their time and they have little time left to focus on other business. The proactive disclosure is the answer to this objection. The more a department is proactive, the lesser information requests will it receive and subsequently has to spent lesser time respond to information requests.

This study aims to capture the status of proactive disclosure in the KP through a set of questions as given in section 5 of the KP RTI Act, 2013. It also helps to identify the government departments openly sharing information with public as required by the RTI law. This report has a potential to help different governmental departments to enhance their websites by sharing relevant information and making their online presence more meaningful and in compliance with the relevant law.

Methodology:

This Report measures the status of openness and online proactive disclosure of information on the in provincial departments of the Khyber Pakhtunkhwah. The state of proactive disclosure is measured as against the different criteria as mentioned in Section 5 of The Khyber Paktunkhwah Right to Information Act 2013.

Each question is scored on varying range of points to further help the report better reflect the degree of sharing and openness over the time. Each question is scored from a numerical range of 0 to 10, where 0 equates "doesn't meet the provision", and 10 equates "completely follows the provision". The numerical scale is further divided in subsets of three:

- The first range 0 -3 represents "no or very low compliance;
- The second range 4-7 shows "medium level of compliance";
- The last 8 10 range shows a very good or maximum level of compliance

Score sheet criteria

Following is the checklist used to score the websites of different departments of the KP. Criteria (a) through (I) used in the score sheet are based on the section 5 of the Khyber Pakhtunkhwah Right to Information Act 2013;

(a) Acts and subordinate legislation such as rules, regulations, notifications, bye-laws, manuals and orders having the force of law in the Province, including being made available at a reasonable price at an adequate number of outlets to ensure reasonable access by the public;

(b) Information about the public body, including its organization, functions, duties, powers and any services it provides to the public;

(c) A directory of its officers and employees, including a description of their powers and functions and their respective remunerations, perks and privileges;

(d) Norms and criteria set by the public body for the discharge of its functions, including any rules, manuals or policies used by its employees to this end;

(e) Description of its decision making processes and any opportunities for the public to provide input into or be consulted about decisions;

(f) Relevant facts and background information relating to important policies and decisions which are being formulated or have been made and which affect the public;

(g) A detailed budget of the public body, including proposed and actual expenditures;

(h) Details about any subsidy or benefit programmes operated by the public body, including details about the amount or benefits provided and the beneficiaries;

(i) Particulars of the recipients of concessions, permits, licenses or authorizations granted by the public body;

(j) The categories of information held by the public body;

(k) a description of the manner in which requests for information may be made to the public body, including the name, title and contact details of all designated officers; and

(I) Such other information as may be prescribed.

Sample:

The sample consists of total thirty (30) departments. It includes websites being run by provincial departments of KP and some special websites of independent or autonomous institutions of KP. The results of this study are shown in a RTI Score Sheets separately for each department.

Scoring is based upon the section 5 of the Khyber Pakhtunkhwah Right to Information Act 2013. All eleven (11) criteria have total weight age of 110 points. For any criteria not applicable for a certain department, it was marked as N/A and total marks are adjusted accordingly.

Scope of the Study

This study only gauges the websites of provincial departments against the 'publication and availability of records' section of the KP Right to Information Act 2013 (Section 5). This study does not take the stock of information released by the department through other means like annual reports, publishing in newspaper, advertisement in media and notice boards etc. There is every possibility that this study assign minimum points for disclosure of certain information online but that information might have already been released to public through other means.

































Proactive Disclosure Clause- Department Wise Comparison
