Executive Summary:

This report evaluates the websites of provincial departments of the Punjab against the proactive disclosure clause of the Punjab Transparency and Right to Information Act, 2013. This report is the first in series of reports to be compiled and launched for the provincial government departments and federal ministries.

The report found that majority of websites maintained by public bodies is properly designed and easily accessible by internet users. However, it discovered a significant gap between the requirements of the Section 4 of the act and what has been actually disclosed on the websites of the provincial departments. It was also discovered during the study that some important departments like the Department of Communication and Works, Home department, Youth Affairs, Sports, Archeology & Tourism department and Transport department do not even have dedicated and established websites. Absence of these websites deprives citizens to have easy access to the activities of government departments. Links and sections of few websites did not open which shows the low maintenance of websites of Provincial departments of Punjab.

This report shows a positive trend where some departments have started disclosing pro-actively their budget estimates and expenditures although in some cases the figures were not updated. This is a leap forward for fiscal transparency. However, such practices need to be adopted permanently by all departments so that a culture of transparency is created in public departments.

In order to show compliance to RTI law, some departments have created a separate section of RTI on their websites, but there is hardly any department who has shown complete compliance to section 4 of the said law. One common omission is the disclosure of remuneration, perks and privilege of the public officials which is a mandatory requirement under Section 4(g). Only the Lahore High Court, technically a special institution under the Punjab Government, has disclosed this information and that we know was done on the advice of the Punjab Information Commission. It is evident from a thin number of websites having an 'RTI Section' that the departments lack proper awareness about the legal obligations as mentioned in Punjab T&RTI Act 2013.

Introduction:

The world is witnessing a digital era where information sharing is quick and through one window of Televisions, laptops and mobile screens. The growing number of internet users and people's online presence has subsequently raised the demand for improving access to government documents through better use of the web; which in turn will lead to openness and transparency through online platforms. This juncture has brought right to information laws at a vertex. Right to information laws bound the government bodies to proactively disclose information regarding the people's interests. With the higher presence of people online, government departments has taken their web presence seriously and tend to be accessible or proactively disclose information through department's website.

Like all good RTI laws, Punjab T&RTI Act 2013 also has a strong proactive disclosure clause. By proactive disclosure, we mean that certain information should be released to public by the government without citizens sending formal request to information. At CPDI, we believe that right to information regime is basically based on this proactive disclosure of information by government. As right to information culture slowly taking roots in Pakistan, one major observation comes from public officials is that information requests take too much of their time and they have little time left to focus on other business. The proactive disclosure is the answer to this objection. The more a department is proactive, the lesser information requests will it receive and subsequently has to spent lesser time respond to information requests.

The study aims to capture the status of proactive disclosure in the Punjab through a set of questions as given in section 4 of the Punjab T&RTI Act, 2013. It also helps to identify the government departments openly sharing information with public as required by the RTI law. This report has a potential to help different governmental departments to enhance their websites by sharing relevant information and making their online presence more meaningful and in compliance with the relevant law.

All websites mentioned in this study were last accessed on July 8, 2018

Methodology:

This Report measures the status of openness and proactive disclosure of information on the websites of provincial departments of the Punjab. The state of proactive disclosure is measured as against the different criteria (sub-section) of as mentioned in Section 4 of The Punjab Transparency and Right to Information Act 2013.

Each question is scored on varying range of points to further help the report better reflect the degree of sharing and openness over the time. Each question is scored from a numerical range of 0 to 10, where 0 equates “doesn’t meet the provision”, and 10 equates “completely follows the provision”. The numerical scale is further divided in subsets of three:

- *The first range 0 -3 represents “no or very low compliance;*
- *The second range 4- 7 shows “medium level of compliance”;*
- *The last 8 – 10 range shows a very good or maximum level of compliance*

Score sheet criteria

Following is the checklist used to score the websites of different departments of the Punjab. Criteria (a) through (l) used in the score sheet are based on the section 4 of the Punjab Transparency and RTI Act 2013;

- (a) Particulars of the public body, its functions and duties;
- (b) Powers and functions of its officers and employees;
- (c) Norms and criteria set by the public body for the discharge of its functions;
- (d) Acts, Ordinances, rules, regulations, notifications, circulars and other legal Instruments being enforced, issued or used by the public body in the discharge of its functions;
- (e) A statement of categories of information being held by the public body;
- (f) A description of its decision-making processes and any opportunities for the public to provide input into or be consulted about decisions;
- (g) A directory of its officers and employees with their respective remuneration perk and privileges;
- (h) Budget of the public body including details of all proposed and actual expenditures;
- (l) Amount of subsidy and details of beneficiaries if the public body provides any subsidy;
- (j) Particulars of the recipients of concessions, permits or authorizations granted by the public body;
- (K) Facilities available with the public body for obtaining information held by it;
- (l) Name, designation and other particulars of the public information officer of the public body; and
- (m) Any other information that the Government may notify in the official Gazette.

Sample:

The sample consists of total thirty seven (37) websites. It includes websites being run by provincial departments of Punjab and some special websites of independent or autonomous institutions of Punjab. The results of this study are shown in a RTI Score Sheets separately for each department.

Scoring is based upon the section 4 of the Punjab Transparency and RTI Act, 2013. All twelve (12) criteria have total weight age of 120 points. For any criteria not applicable for a certain department, it was marked as N/A and total marks are adjusted accordingly.

Scope of the Study

This study only gauges the websites of provincial departments against the proactive disclosure section of the Punjab Transparency and Right to Information Act (Section 4). This study does not take the stock of information released by the department through other means like annual reports, publishing in newspaper, advertisement in media and notice boards etc. There is every possibility that this study assign minimum points for disclosure of certain information on website but that information might have already been released to public through other means.


Sec 4(h) budget of the public body proposed and actual expenditures;






